## PUBLICATION REQUIREMENTS

All articles submitted to the editorial office undergo double blind review. If the article was revised by the author in the process of preparing for publication, the date of receipt is the day of receipt of the final version.

### DESIGN INSTRUCTIONS

Manuscripts are formatted using Microsoft Word. Submitted in electronic version and PDF format. Tables and figures are placed in the text of the article.

**The works are presented in the following sequence:**

**1. Title page**

a. MRNTI (interstate rubricator of scientific and technical information) (size 14 points).

b. UDC.

in. The title of the article (in bold, size 16 points).

d. The initials and surname of the author / authors (in bold, size 14 points).

e. The full name of the institution / institutions, country, postal code, city, street, house (size 14 points), Each author is associated with his organization using an upper case number as shown below:

and. All of the above is in Kazakh. If the article is in Kazakh or English - in Russian (size 12 points).



2. The text of the article (size 14 points).

3. References (size 12 points).

4. Corresponding author: full name. (in full), academic / academic degree, academic title, position and place of work, telephone, E-mail (12 point pt).

5. List of all authors with the indication of full name. (in full), academic / academic degree, academic title, position and place of work.

The number of words in original articles should not exceed 4,000 (excluding annotation, bibliography, tables, figures).

## **MANUSCRIPT SECTIONS**

### **Title page**

The title for original articles should not exceed 100 characters, and for articles in the "Work Experience. Practical Cases"- 80 characters. The abstract / resume should not exceed 400 words and 200 words for cases from practice / work experience. The abstracts of original articles should contain: purpose, material and methods, results and conclusion. Abbreviations are not allowed. The number of keywords should not be more than 5.

### **Text**

The text of the original articles contains relevance or introduction, purpose, material and research methods, results and their discussion, conclusion and / or conclusions.

The purpose of the study should be clearly defined, not in the form of a problem.

The material and methods should include the date and design of the study, a description of the object / subject of the study, listing or, if necessary, a description of all specific methods, including biometric.

The results contain the obtained data and statistical processing.

The discussion contains the interpretation of the research results in comparison with similar data from other researchers listed in the literature list. Abbreviations should be avoided whenever possible. They can be used if they were previously indicated in brackets.

References, tables, figures should be numbered.

The literature list is limited to 30 for the original study and 50 for the review. All units of measurement should be quoted in accordance with international standards for letter designation.

### **References**

All literature is in the original language. The list of references is typed in italics, type size 12 points. Links should be sequentially numbered in the order in which they are first mentioned in the text in Arabic numerals in square brackets []. The number should be placed at the end of the sentence before the period. If several numbers are given, then they are set in ascending order, separated by commas [1,2,6,10]. If three or more digits are given, the first and last are indicated with a



hyphen [1-5]. If the author / authors are given in the text, then the initials go first, and then the surname; then the number in accordance with the list of references [1]. The literature index should include the following information: the surname and initials of the author / authors (if there are four authors, then they are indicated after the title of the article or book; if there are more than four authors, the first three and further and "others" are given), the name of the journal or collection (materials, abstracts, etc.), year, volume (issue), number, first and last pages. For books and articles from collections, you must specify: city, publisher, year, pages. The title of the journal may be abbreviated in accordance with the Index Medicus system.

The electronic version of the article must be created using a text editor Microsoft Word of any version.

Book orientation. Font - Times New Roman. Kegel depending on the section - 10,12,14,16 points.

Line spacing is single. There are no transfers. Indent (red line) - 1.5 cm.

Top, bottom and right margins - 2 cm, left - 4 cm.

When typing the main text, it is not allowed to set two or more characters "space" in a row, paragraph and other indents.

Numbered and bulleted lists are generated only automatically.

The name of the figures is placed under them, aligned to the left.

Tables (size 10 or 12 points) should have titles located above the table on the left, be compact, clear, and have links in the text. The headings of the columns must exactly match their content. Mathematical and chemical formulas must be clear, indicating on the margins the letters of the alphabet (lowercase, uppercase, Latin, Greek), exponents, superscripts and subscripts.
