1.1 The program is intended for applicants in the field of "Health" of the group of the educational program 6B10101 –"Nursing" with a training period of 10 months.

2. MAIN PART

3.1 Brief information

According to paragraph 6 of Chapter 2 of the Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 31, 2018 No. 600 "On approval of Standard rules for admission to educational organizations implementing educational programs of higher and postgraduate education", citizens of the Republic of Kazakhstan with technical and vocational, post-secondary or higher education are accepted for training in educational programs of higher education education that provides for shorter training periods.

The entrance exam is held on the basis of NJSC "Astana Medical University", in computer classes, in an offline format, on the Moodle platform.

Requirements for the previous level of education:

Post-secondary education in the specialty "Nursing" with the qualification "Applied Bachelor of Nursing", work experience of at least 1 year for graduates of the educational program of applied baccalaureate with a term of study of 3 years 6 months and without presenting requirements for work experience for graduates of the educational program of applied baccalaureate with study period 1 year 6 months.

3.3 Venue of the special exam

Venue: Astana, st. Beibitshilik, 49A.

Admission to the audience to pass the entrance exam is carried out upon presentation of an identity document. At the same time, the entrance exam is held in classrooms (rooms) equipped with video and (or) audio recording.

3.4 The form of the entrance exam:

- testing.

The list of test items was approved at the meeting of the Academic Council of NJSC "Astana Medical University" Protocol №5 dated May 29, 2023. The Department of Nursing reviewed the test items and recommended for use as a differential diagnostic questionnaire for applicants.

List of documents:

- 1) an application addressed to the Rector of the University in the prescribed form;
- 2) document of education (original);
- 3) identity document (required for identification);
- 4) 6 photo cards measuring 3 x 4 centimeters;
- 5) a medical certificate in the form 075/y in electronic format, approved by the order of the Acting Minister of Health of the Republic of Kazakhstan dated October 30, 2020 No. KR DSM-175/2020 "On approval of forms of accounting documentation in the field of healthcare" (registered in the Register of State Registration of Regulatory legal Acts under No. 21579)
- 6) extract from the statement on passing the psychometric exam (for applicants for educational programs "Nursing", "Kinesitherapy", "Occupational Therapy", "Dentistry");



7) Persons who have documents on technical and vocational, post-secondary education, who have confirmed their qualifications and have at least one year of work experience in the specialty, additionally submit one of the documents provided for in Article 35 of the Labor Code of the Republic of Kazakhstan.

3.6 Exam material

Test questions - 50 (in Kazakh and Russian).

Topics for preparing for test questions:

1. Nursing. Nursing process: definition, stages, features.
2. Gastric lavage with a probe.
3. Sanitary and epidemiological requirements in medical institutions.

Disinfection: types, features.

4. Punctures: indications, technique.
5. Enteral routes of drug administration.
6. Inhalation route of drug administration.
7. Evaluation of the functional state of the patient (measurement of respiratory rate, pulse, blood pressure).
8. The main types of medical institutions.
9. Parenteral administration of drugs. Features of intradermal, subcutaneous injections and administration of drugs.
10. Dosage forms of drugs: types and features.
11. Rules for the storage of medicines.
12. Bladder catheterization.
13. Bedsores.
14. Preparing the patient for laboratory tests.

3.7. Entrance exam results

There are 50 questions in total.

For each question: 1 correct answer.

Each correct answer is worth 1 point.

The maximum score is 50 (100%).

Passing score - 30 (60%).

Time for testing - 75 minutes.
